# 4. Amendment: U-Pass Motion (Approval via email)

Amendment of motion (i.e., the previous motion that was approved in the February council meeting):

Motion to Approve U-Pass fees increase between \$1.68 - \$3.37 (from \$115.38 to \$118.06-\$119.31) according to Saskatchewan January 2022 Consumer Price Index (CPI)

As per GSA's contract with the Saskatoon Transit, the U-Pass fee increases every year using the Saskatoon CPI from January 2022. As mentioned in our previous meeting, we have

approved the increase of this fee, pending the release of this information. The CPI for Saskatoon is 3.8% as of January 2022, which increases the fee from \$115.38 to \$119.65.

Here is the explanation: 115.38 (current fee) - 3 (admin fee) = 112.38 112.38 x (3.8/100) = 116.65 116.65 + 3 (admin fee) = 119.65

The new amount for the next year will be: \$119.65 Therefore, the GSA Board of Directors ask the following motion to be amended:

Motion to approve of the U-Pass fee increase from 115.38 to 119.65 to be effective on the 2022-2023 Academic year, according to Saskatoon January 2022 Consumer Price Index (CPI) of 3.8%. (Moradi/Zahan)
