GSA President's Report (September-October 2022) to GSA Council Members

Dear GSA Council Members,

Please find the GSA President's monthly activity summary from September 9, 2022, to October 11, 2022, as listed below in order of importance of the activities.

1. GSA Executive's monthly meeting with University President and his team, September 20, 2022

The GSA executives meet with the University of Saskatchewan President Professor Peter Stoicheff and his leadership team, including various university provosts, vice presidents, and deans. The GSA president and vice-president of finance presented the current GSA executive committee's advocacy priorities and service improvements. Followed by the meeting, the GSA president submitted a list of the Advocacy Works and Priorities of the 2022-2023 GSA Executive Committee to the University President as listed below.

Advocacy Priorities of 2022-2023 GSA Executive Committee

- I. To advocate for a minimum guaranteed funding for all thesis-based graduate students not less than the equivalent amount of Saskatchewan's minimum wage salary.
- II. To advocate to ensure a university-wide minimum guaranteed scholarship/stipend for thesis-based graduate students for a duration that is compatible with the median degree completion time of the University of Saskatchewan graduates.
- III. Work with various colleges to help bring down the University of Saskatchewan's median graduation timeline under the U15 median.
- IV. Advocacy for the introduction of part-time study opportunities coupled with part-time tuition fee options for part-time students.

- V. Advocacy for the reduction/removal of international tuition differential for master's students.
- VI. A mandatory graduate evaluation committee report following each meeting for all thesis-based programs.
- VII. Advocacy for service improvement at the Student Wellness Centre, including an introduction of walk-in clinic service for all University of Saskatchewan students.
- VIII. Advocacy for broader and faster adoption of Equity, Diversity, and Inclusion (EDI) principle across the university. Expanding the anti-racism and anti-oppression training beyond top-level university leaders, especially for faculty members, managers, and directors of different university services.
- IX. Advocacy for the introduction of paid maternity leave for graduate students (currently, a limited number of colleges offer such benefits at USASK).
- X. Advocacy for the introduction of a university-wide emergency graduate childcare bursary.
- XI. Advocacy for a seat on the University of Saskatchewan Board of Governors.

2. Planning and Priorities Committee Meeting, September 14, 2022

The GSA president attended the university's Planning and Priorities Committee Meeting, where the provost and vice-president academic, Professor Airini, presented the University of Saskatchewan's goals and visions for 2025. The GSA president advocated taking measures to help the University of Saskatchewan improve its world ranking and global recognition.

3. CGPS Executive & Coordinating Committee Meeting, September 15, 2022

The GSA president attended the CGPS Executive & Coordinating Committee Meeting chaired by the dean of CGPS, Professor Debby Burshtyn. It is a meeting where the chair of different academic committees of the university update about their ongoing work. The GSA president also needs to update GSA's ongoing activities.

4. GSA Executive Monthly Meeting, September 19, 2022

The GSA executives met for the monthly meeting on September 19, 2022. Issues discussed at the meeting include the hybrid format GSA council meeting, review of the GSA fall

orientation event, upcoming Canadian Federation of National Graduate Caucus meeting in November 2022 at Ottawa. The detailed meeting minutes will be made available in the next council meeting.

5. Fee Review Committee - Orientation Meeting, September 20, 2022

The GSA president attended the University's Fee Review Committee. It was an orientation meeting for this committee where the working procedure for this committee was discussed.

6. University Council Orientation Meeting, September 27, 2022

The GSA president and VP of Academic and Student Affairs attended the university council orientation meeting, where new members were introduced to the university council's terms of reference and working procedure.

7. University Council Meeting September 29, 2022

The GSA president attended the introductory CGPS Executive & Coordinating Committee Meeting. The GSA president has updated the council members about GSA activities since the current executive committee started its term. The GSA president emphasized the prioritized advocacy works of the current executive committee.

8. Governance Committee Meeting, October 4, 2022

The GSA president attended University's Governance Committee meeting and provided constructive feedback about various policies under review. Because of the confidentiality agreement, meeting details cannot be shared.

9. CGPS Faculty Council (GPSFC) Meeting, October 6, 2022

The GSA presidents and other executives attended the CGPS Faculty Council (GPSFC) Meeting. The GSA president updated the faculty council members about GSA activities since the current executive committee's priorities and advocacy works. The dean of CGPS presented her proposal for future graduate funding and scholarship for a thesis-based program. It was a great pleasure to see that the dean of CGPS proposed graduate funding and scholarship policies that the GSA has been advocating since last year. The dean of CGPS proposed some policies which were the top three election platforms of the current

GSA president, including a university-wide minimum guaranteed funding for all thesis-based graduate students, four years of guaranteed funding for Ph.D. students, and paid parental leave for graduate students.

10. GSA Executive Monthly Meeting, October 9, 2022

The GSA executives met for the monthly meeting on October 9, 2022. Issues discussed at the meeting include advocacy work about the university-wide introduction of equity, diversity, and inclusion principles; configuring GSA commons with facilities that will enable council members to join future council meetings in hybrid formats. The meeting minutes will be made available in the next council meeting.

11. Representing GSA as the Vice President of the Student and Learning Search Committee (September 9 to October 11, 2022)

The GSA president attended more than ten search committee meetings for the Vice President of Student and Learning at the University of Saskatchewan. Because of the confidentiality agreement, meeting details cannot be shared.

12. Representing GSA at the dean of the College of Arts and Science Search Committee (September 9 to October 11, 2022)

The GSA president attended six search committee meetings for the dean of the College of Arts and Science of the University of Saskatchewan. Because of the confidentiality agreement, meeting details cannot be shared.
